NOTICE OF INTERNATIONAL CALL FOR TENDERS

Reference No: 031/2017/00AS

1. The West African Health Organisation (WAHO) received a grant from the African Development Bank (AfDB) to implement *the Strengthening West Africa's Public Health system (SWAPHS) Project* and intends to use part of the proceeds of this grant for payments for the Supply and Delivery of Mobile Laboratories to three Member States of ECOWAS.
2. The Director General of WAHO is hereby calling for international tenders for the supply and delivery of mobile laboratories to Burkina Faso, Mali and Niger.
3. All qualified suppliers or groups of suppliers in ECOWAS Member States are eligible to participate in this competitive bid, provided that they are not serving any prohibition or suspension penalty from bidding and are in good standing with the Government of the countries where they have their branches or head office.
4. Services covered by this international call for tenders consist of three (3) lots, designated as follows:

NB: Tenderers may apply for one or several or all the lots. In the event that they tender for several or all of the lots, they must submit a separate application for each lot.

5. Delivery period should not exceed three (3) months.

Payment can also be by certified cheque or bank transfer.

The bids consisting of **one (1) original and three (03) copies**, in compliance with the ToRs, should be sent/submitted to the following address: **West African Health Organisation - 01 BP 153 Bobo-Dioulasso 01 – Avenue Ouezzin Coulibaly - Tel. : (+226) 20 97 01 00 / 20 97 57 75 - Burkina Faso** not later than **23 November 2017 by 11:00 am**.


The bids will be opened publicly, in the presence of bidders' representatives who wish to attend, on **23 November 2017, at 11.30 am** in the conference room of **the West African Health Organisation (WAHO) - 01 BP 153 Bobo-Dioulasso 01 - Avenue Ouezzin Coulibaly - Tel. : (+226) 20 97 01 00 / 20 97 57 75 - Burkina Faso**.

Should the bid be sent in by post or via other submission means, WAHO would not be held liable for the non-receipt of such.

Bidders are required to submit a tender guarantee of **three million and five hundred thousand (3,500,000) FCFA** issued by a bank for **each lot**.

9. Bidders shall remain bound by their offers for a maximum of **120 days** as from the date of submission of tenders.
10. Below is a short description of the qualifying criteria to be met by bidders:
 - Must have successfully executed, as the main supplier, at least one (01) contract, whose nature and complexity are similar to the services to be provided, over the last five (05) years;
 - Provide the brochure and authorization from the manufacturer (Certificate of Origin);
 - Provide information on the after-sales service;
 - Must have made a minimum average turnover of 300,000,000 FCFA within the last three (03) years or since incorporation of the company.
11. WAHO reserves the right to take no action on all or part of this notice of call for tenders.
