1. The West African Health Organization (WAHO) has budgeted for the construction and rehabilitation of the Muraz Club in its 2019 Budget.
2. By this notice, the Director General of WAHO is launching an open call for tenders for the work to be carried out in Bobo-Dioulasso.
3. Participation in bidding is open to all qualified companies or groups of companies in the ECOWAS region, provided that they are not subject to prohibition or suspension and in good standing with the Administration of their country of establishment or fixed base.
4. The works, which are the subject of this call for tenders, are made up of a single lot, designated as follows:
